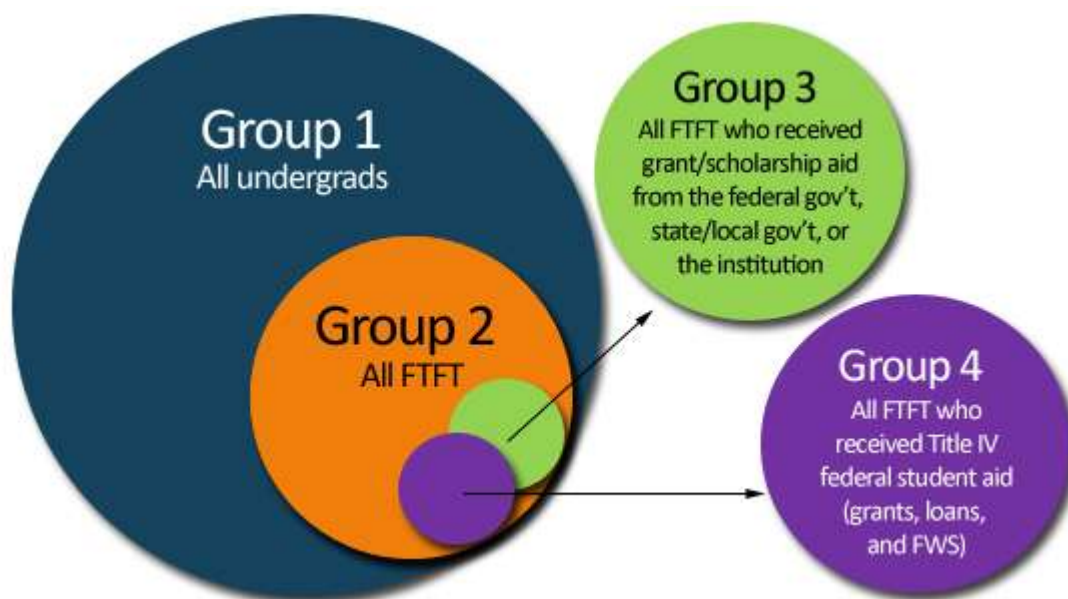

Reason: Due to more stringent credit restrictions related to the national "credit crunch", fewer students were approved for private loans for 2009-2010 but those that were, borrowed more. We believe this was related to the economic downturn which meant that families had less disposable income to contribute to their child's cost of attendance, and thus the students had to borrow more.
