2. **Question:** Do you know what type and style the existing dampers are?

Answer: The type and style of the existing dampers varies as install occurred from 1970 to 2020.

3. **Question:** Will MUHC provide an asset ID list for inventory you want vendor to use or will the asset# already been tagged at the damper?

Answer: MUHC will provide numbered labels for those that are not tagged but most dampers are already tagged at the damper.

4. **Question:** Can vendor note "N/A" if damper serial# and Model# are not present?

Answer: MUHC expects the vendor to make a good faith effort to identify the damper serial number and the model number but will accept a N/A if the information cannot be identified.

5. **Question:** What is the factory name of a damper? Is that Ruskin, Greenheck, etc.....?

Answer: Yes, the manufacturer.

6. **Question:** Duct service would require mechanical drawings, will MUHC provide?

Answer: MUHC will provide mechanical drawings to the awarded vendor, if available.

7. **Question:** Are there any special wage requirements for this work i.e. prevailing wage?

Answer: The respondent should comply with all applicable Federal and State laws and regulations, including the federal prevailing wage guidelines outlined in FAR clause 52.222-41.
