 - (a) The FS reads that Columbia received 66,410,447.62 for general State Appropriations. In this analysis we added 555,103 for general state appropriations that were transferred to
 - (b) Inclusive of \$244,408 emergency appropriation for optometry recorded as received and \$69,666 in funds appropriated the prior (80) year.
 - (c) Increased UMC amount by \$460,000 (from the Financial statement amount) for F21C incorrectly recorded as restricted
