- Secondary Platforms
 - Amendment 6, ballot initiative
 - Yes: allow state const to require photo ID to vote
 - No: status quo
 - Student Impact
 - Specifically excludes student ID
 - Right now, we can
 - Out of state need passport or MO ID
 - Could impact finances, taxes
 - State would pay costs
 - Pros: Voter Fraud
 - ASUM Impact
 - Could decrease ability to register students
 - Millennials now largest potential voting block n MO
 - Equal portion nationally w/ Baby Boomers
 - Registrations give AUSM leverage
 - Recommendation: oppose amendment 6
 - Decrease accessibility for out of state, lower leveraging power, decrease student input, could lead to funding decreases
 - Geoff: needs compelling reason to restrict
 - Kaitie: allow for new academic perspectives and cultures to foster
