

Missouri University of Science and Technology CRR 110.015 Facilities Needs and Reporting

CRR 110.015 was established to keep the facilities of the University of Missouri system in good condition to ensure the needs of the University’s education and research missions are met. CRR 110.015 requires an annual investment to maintain a Campus Facilities Condition Needs Index (FCNI) of 0.30 or lower for Education and General (E&G) facilities. Auxiliary (Non-E&G) facilities have a target of 1% of the current building’s replacement value. Current Replacement Value is based on values in the FY 2023 Facilities Insurance Report.

Current status of Education and General (E&G) Facilities

Missouri S&T currently has a campus FCNI of 0.23 which is below the CRR 110.015 goal of 0.30, and projected \$287.6 million facilities needs, with current deferred needs of \$136.9 million. Currently, ten (10) facilities need major renovations, and fourteen (14) facilities need total renovations or replacements. Please see the list of buildings on page 3 of this report for additional details.

Missouri S&T spent \$26.8 million for CRR 110.015 for FY 2025. Projects includes Schrenk Hall – East (\$4.5M), Hwy 63 Underpass Replacement(\$2.1M) and Rolla Building Renovation (\$1.8M). The target goal in FY 2026 for spending to maintain the FCNI of 0.23 is \$24.4 million.
