- The Construction Schedule shall commence on the date the "Notice to Proceed" is received from Owner. The Contractor shall complete the Work Authorization within «ProcessFields_Contractofdaysspelledout» («ProcessFields_ContractNumberofdaysNumeri») calendar days of receipt of the Notice to Proceed.
- Contractor agrees that it is fully informed regarding all of the conditions affecting the work to be done under, and as to the labor, supervision, materials, equipment, transportation, tools, and plant to be furnished for the completion of this Work Authorization and also agrees that its information was secured by personal investigation and research and not from any estimates or representations of any officer, agent or employee of Owner.
- For the complete performance of Contractor’s undertakings and promises under this Work Authorization, Owner shall cause to be paid to the Contractor the sum of «ProcessFields_ContractSumlongspelling» («ProcessFields_CommitmentTotalCost») subject to any deductions as provided in the Contract Documents.
- The Work Authorization price hereunder shall be payable as provided by law upon certification of the Owner that the same is due and payable under the terms of the Contract.
