# Enrollment Projections Report, 2007 Office of Institutional Research and Planning University of Missouri System

# **Executive Summary**

The *Enrollment Projections Report*, 2007 includes University of Missouri enrollment projections for each of the four campuses and the System. Organized according to student level, it provides headcount and credit hour projections for the next five years. Each campus made headcount and credit hour projections, which are presented in this report unaltered. The totals for the UM System were calculated by adding totals from each of the four UM campuses. Special thanks to the following representatives who provided the enrollment projections for their campus: Alysha O'Neil at UM-Columbia, Mel Tyler at UM-Kansas City, Carol Heddinghaus at UM-Rolla, and Greg McCalley at UM-St. Louis.

These enrollment projections were made in consideration of the enrollment management plans on each campus, in concert with the impact that these projections will have on the budget for each campus.

The highlights of the report include:

- Total on-campus, on-schedule headcount at the University of Missouri System is expected to increase 2% from 56,276 in the fall of 2006 to 57,557 in the fall of 2011. The Columbia campus anticipates a 1% decline in enrollment, while the Kansas City, Rolla, and St. Louis campuses expect increases of 1%, 2%, and 11%, respectively (Table 1).
- System-wide, undergraduate headcount is expected to increase 2% over the next five years (Table 1).
- Over the next five years, overall graduate headcount at UM is expected to increase by 3%. Graduate enrollment is expected to increase 11% on the St. Louis campus. No change in graduate enrollment is expected at the Kansas City and Columbia campuses. A 2% increase in graduate enrollment is predicted for the Rolla campus (Table 1).
- Full-time, first-time freshmen enrollment system-wide at the University of Missouri is projected to remain steady the next five years (Table 2). Although the St. Louis campus anticipates a 16% increase in first-time freshmen enrollment, the Rolla campus is predicting a 6% decrease. No change in first-time freshmen enrollment is expected at the Columbia and Kansas City campuses.
- Over the next five years, the Columbia and Kansas City campuses expect no change in the percentage of undergraduates who are Missouri residents, 86% and 72%, respectively (Table 3). The Rolla campus predicts a 2% increase in resident undergraduates and the St. Louis campus predicts a 5% decrease in resident undergraduates. The percentage of resident graduate students is expected to hold steady at 57% on the Columbia campus, 56% on the Kansas City campus, and 32% on the Rolla campus. The St. Louis campus expects a slight decrease in the percentage of resident graduate students.
- Total on-campus, on-schedule credit hours across the System is expected to increase 2% over the next five years (Appendix Table E).

# **Organization of Report**

The text of this report, "Basis for Enrollment Projections by Campus" refers to Tables 1-3 located in the body of the report. Please note, however, that more detailed information about the campus projections can be found in the appendix. Organized by campus, the tables in the appendix illustrate expected enrollment changes at the lower and upper-division undergraduate levels, projections for each professional program (e.g., law, pharmacy, optometry, etc.), and enrollment forecasts at the graduate level. The appendix also includes more detailed information concerning the percentage of Missouri residents by level and the percentage of full-time students by level.

# Basis for On-Campus Enrollment Projections by Campus

Making these projections requires the careful consideration of factors influencing future enrollments. For instance, each of the following could potentially influence enrollment: the effectiveness of an institution's recruiting and marketing strategy; shifts in the number of seniors graduating from high school; the national economy and state budget cuts in higher education; retention rates of students enrolled; and current tuition levels along with anticipated increases. In addition, the competitiveness of other institutions vying for the same students; the availability of transfer students; changes in admission standards; new state policies or programs; and high school student interest in specific fields can all play a role. The basis for projecting enrollment growth at each campus is unique.

#### UM-Columbia

- Total on-campus, on-schedule headcount is expected to decrease 1% from 26,764 in 2006 to 26,538 in 2011 (Table 1).
- The number of high school graduates in Missouri, which is the strongest predictor of undergraduates, is expected to decrease slightly beginning in 2009. However, MU is taking steps now that will mitigate the impact of the projected decline. The steps include increased recruitment efforts throughout the Midwest region; new access initiatives such as the Missouri College Guide Program funded by Jack Kent Cooke Foundation; and enhanced partnerships with the community colleges. In addition, an analysis of the high schools that traditionally send the most graduates to MU indicate they will have a smaller enrollment decline than the rest of the state.
- Graduate enrollment is expected to remain steady at MU over the next five years (Table 1).
- First-professional enrollment at MU is expected to increase by 2% through 2011 (Appendix Table A).

## UM-Kansas City

• The University of Missouri-Kansas City is projecting a relatively flat student headcount out to Fall 2011 with the exception of the new satellite Pharmacy program in Columbia, which will be adding 28 students each year to reach maximum capacity in 2010 then to remain steady afterwards (Appendix Table B). The additional increase in pharmacy students will produce an overall 7% increase in first-professional enrollment from 1,509 students in Fall 2006 to 1,621 students in 2011.

## UM-Rolla

- Total on-campus, on-schedule headcount at UM-Rolla is expected to increase 2% from 5,389 in 2006 to 5,511 in 2011 (Table 1). Flat return rates are expected for all levels except seniors. The returning senior rates have been dropped in anticipation of higher and faster graduation rates. The resulting returning student head count from the stable freshmen through junior return rates and lowered senior return rates will actually increase modestly through Fall 2009, due to previous year's increased new students.
- Total undergraduate enrollment is expected to increase from 4,499 in 2006 to 4,605 in 2011 (Table 1). Transfer and non-degree seeking student projections are based on historical enrollment patterns over the past several years and current applications and deposits received as of March 1. For Fall 2007 to 2011, transfer numbers are expected to remain stable at 240 new incoming students per year.

- A 6% decrease is expected in first-time, degree-seeking freshmen headcount at UM-Rolla from 935 in 2006 to 875 in 2011 (Table 2). The first-time college student projection is based on the number of high school graduates and prospective engineering students projected in Missouri for the coming years and the three year average of admitted students who enroll the following fall semester. Based on applications and deposits received as of March 1 for the fall semester, the projection for Fall 2007 FTC appears to be in line with these estimates.
- Graduate enrollment at UM-Rolla is expected to increase by 2%, from 890 in 2006 to 906 in 2011 (Appendix Table C). New graduate enrollments for Fall 2007 on-campus students were estimated by reviewing the last three year average of admit to new enrollee yield rates. New graduate enrollment for the following years is projected to remain flat. The greatest potential for growth in this cohort will be distance and online students with a projected 50% growth in distance enrollment by Fall 2011.

## UM-St. Louis

- The St. Louis campus expects an 11% increase in total on-campus, on-schedule headcount from 2006 to 2011 (Table 1). Enrollment projections are based on the Strategic Planning document presented to the Board of Curators in December 2006 and the revised five-year UMSL Action Plan.
- While the State of Missouri will experience declines in the number of high school graduates, UMSL will continue efforts to grow its presence in the transfer market. The newly formed Office of Transfer Services and Articulation will help UMSL continue a long tradition of maintaining a strong transfer population. Increased efforts to increase transfer populations will focus on increased scholarship programs, dual admission partnerships and articulation agreements.
- The new Center for Student Success will continue in its work to increase student retention and
  success through programs targeting populations such as probation students, resident students, athletes
  and first-generation students. The Center will also work more closely with students admitted to the
  University as exceptions through a new Freshman Year Experience, Summer Success Programs and
  more intrusive advising and counseling.
- First-time, degree-seeking freshmen headcount is expected to increase from 477 in 2006 to 552 in 2011, an increase of 16% (Table 2). New programs will be implemented to facilitate this projected increase in first-time, freshman enrollment. The scholarship program is currently going through a comprehensive review with recommendations for change geared at attracting more students. The Admissions Office and Center for Student Success are also actively seeking opportunities to increase the admission pipeline through partnerships with high schools, middle schools, elementary schools and various organizations throughout the city such as College Summit and College Bound.

# UM System Total

- Overall, on-campus, on-schedule enrollment for the UM System is expected to increase by 2% over the next five years (Table 1).
- A 5% increase in professional enrollments is expected due partially to the UMKC pharmacy students that will be enrolled at the UMC campus (Table 1).
- Graduate enrollment is expected to increase by 3% (Table 1).
- First-time freshmen enrollment is expected to remain steady over the next five years (Table 2).

• Total student credit hours across the System are expected to increase 2% over the next five years (Appendix Table E).
