### **UM System Continues to Advance Missouri**

Last year, the four campuses and health care enterprise of the University of Missouri System continued to advance the state in ways that touched every county, every day.

From the education of our more than 73,000 students to the hundreds of thousands of patients we cared for...from the million contacts made by our Extension offices to the millions of dollars brought in from licensing novel technologies developed at the university...from the immeasurable support we provided to communities like Joplin, the Bootheel and Northwest Missouri ravaged by natural disasters to the vibrant statewide arts and culture our faculty, graduates, students and staff help cultivate, our university's impact is felt by all.

Our mission—to discover, disseminate, preserve and apply knowledge—has been our historic guide in serving the state and its citizens since our founding more than 170 years ago. But our ability to continue to meet the needs of Missouri and its citizens has been jeopardized by more than a decade of declining state funding that has put our per capita state funding at 45th out of 50 states. That's lower than any of our neighboring states...lower than any state in the Midwest...and lower than any state in the South.

This evening, Gov. Jay Nixon is expected to outline his 2012-13 budget proposal during his annual State of the State Address. While we understand that our still sluggish economy will continue to present budget challenges for the governor and the legislature, we hope all Missourians fully appreciate that higher

#### Retirement Plan Vendor Selected

During last month's regular board meeting, the University of Missouri Board of Curators approved Fidelity <u>Investments</u> as its master administrator to manage the defined contribution portion of the new retirement plan for new employees, as well as its voluntary tax-deferred investment program. By moving to a master administrator, we will still provide employees with an array of investment options, but we will reduce administrative fees by more than half, expand employee services and allow the university to have a more structured, comprehensive retirement approach that benefits employees' retirement savings goals. ## **Protecting the Sanctity of the Classroom**

Last month I issued an <u>executive order</u> regarding the unauthorized redistribution of recordings made in the classroom. The new policy was developed in conjunction with faculty representatives and administrators from all four of our campuses. The primary purpose of the policy is to protect the sanctity of classroom discussions for students so they feel free to contribute their own thoughts and opinions in a safe learning environment without fear that their personal opinions will be disseminated outside the classroom.

The University of Missouri System has long protected the academic freedom of faculty as being essential to the learning process and the new policy provides similar protection for student discussions. This new policy in no way attempts to prohibit students' use of technology, but rather prohibits the unauthorized redistribution of any audio or video outside of the classroom without the instructor's prior consent and the consent of any students who are recorded.
